The PHA has also amended its Administrative Plan to provide for termination of Section 8 rental assistance to a recipient of Section 8 assistance or a member(s) of the recipient's household/family because of their having committed an act or acts of domestic violence, dating violence, sexual assault or stalking.
- 2. The PHA has amended the screening policies and procedure for its Public Housing and Section 8 Programs in order to include therein relevant provisions pertaining to the denial of assistance to applicants and tenants/program participants or members of their households because of their having committed an act or acts of domestic violence, dating violence, sexual assault or stalking.
- 3. The PHA has revised its application form for assistance under its Public Housing and Section 8 Programs in order to reflect therein relevant questions pertaining to the commission of an act or acts of domestic violence, dating violence, sexual assault or stalking.
- 4. The PHA provides all of its Section 8 landlords with copies of the HUD fact sheet entitled "The Violence Against Women Act-Landlord Rights and Responsibilities."
- 5. The PHA encourages all of its Section 8 landlords to incorporate the applicable provisions of the Violence Against Women Act in their lease agreements with Section 8 assisted tenants.
- 6. The PHA is actively seeking to partner with local resource agencies involved in the administration of support programs designed to assist adult and child victims of domestic violence, sexual assault or stalking.

The Capital Fund Program Annual Statement/Annual Statement/Performance and Evaluation Report must be submitted annually even if there is no change.
- 4. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Board or Boards in developing the Plan, and considered the recommendations of the Board or Boards (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the manner in which the Plan addresses these recommendations.
- 5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment.
- The PHA certifies that it will carry out the Plan in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, section 504 of the Rehabilitation Act of 1973, and title II of the Americans with Disabilities Act of 1990.
- 7. - 11. The PHA will comply with the requirements of section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
- The PHA will comply with acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implementing regulations at 49 CFR Part 24 as applicable.

- The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
- 14. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
- 15. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
- The PHA will keep records in accordance with 24 CFR 85.20 and facilitate an effective audit to determine compliance with program requirements.
- The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
